

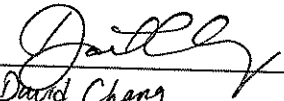
DFW Curling Club Meeting Minutes

The following is a summary of the topics of discussion, decisions and action items from the meeting. It is not meant to be a transcript of what was said and by whom. Please notify the author immediately upon finding any discrepancies.

1. Rebecca Hopkins reported that so far, only 8 or 9 people have paid for the summer league via Paypal online. She also reported that the last payment made to the Stars Center for January/February ice was \$4,250.00, and the Club currently has \$5,105.00 in the bank.
2. Because of the current low number of summer league registrants, a suggestion was made to consider opening up the summer league to existing Club members if not enough people on the "hot list" sign up by April 23.
Action: **Judy Willingham** to contact Chuck McCue to make sure he sends another email to all "hot list" members to tell them that they need to sign up and pay their summer league dues within the next 10 days so that the Club can set up the draw by April 21.
3. Dan Johnson received the Potomac Curling Club new members' handbook from Kathleen Harlow and has had the handbook reviewed and revised.
Action: **Dan Johnson** to create a new cover page for the handbook and will then email the entire document to **David Villegas**, who will print out copies of the handbook for distribution to new members during the summer.
4. Discussion about creating two banners for the Club to be displayed at the Stars Center and/or at other events. Rebecca Hopkins reported that the Club had previously budgeted \$250.00 for this.
Action: **Judy Willingham** to look further into creating two banners; will check with Don Kleppe to see if he can give us a deal and will also explore other alternatives and present to the Board various options for the banners later in the summer. **David Villegas** to send Judy Willingham a .pdf file with the Club logo for her to use in connection with the banners.

5. A suggestion was made that the 1st week of the 2006-07 season be more of a social gathering for the members to get to know each other and to use the ice time for practice and instruction rather than to have an actual game.
Action: Re-visit this issue in July or August as the 2006-07 season gets closer and after we have a better idea of how many new members we will have.
6. A suggestion was made to do away with the \$1 weekly rental for brooms and to instead offer the brooms for sale or to offer them for rent for a longer period of time. No action taken at this time.
7. A suggestion was made to keep a more accurate list of substitute players over the course of the season. No action taken at this time.
